Administrative Update

- Meeting with Director of Marking and Community Outreach for IU Hospital West – Day of Service, June 6th 2014, Trails Dedicated
- Website Gus template, current website updates, wait until park rename (?)
- 5 year Master Plan Timeline for completion and outline (printed) Need board assistance as this is a job for a team(s)!
- Meeting with Visit Hendricks County Entering the conference venue market (week day rentals)
- Researched prices of local wedding venue providers to determine 2015 pricing
 - Increasing Township and out of Township prices by \$500 for wedding day packages (\$1,500 Township;\$2,000 Out of Township) – this positions us on the high-low end and should guarantee we still fill up for 2015
 - Created day before packages to provide time for set-up, rehearsals and rehearsal dinners – previously were told that if 30 days in advance of event no one booked the space they could have it for free from 11am-11pm (this does not impact free space usage during the week) which was creating a negative impact
- Job postings added for Event Staff, Maintenance Part-time, Maintenance Part-Time weekend, and Administrative Assistant (emphasis on special events and programs) – Jay Clark moving into full-time after Pat leaves on Nov 29th
- Sales Facility Rentals Revenue will slow down Need to focus on increasing revenue during "slow season".

- Ghosts & Goblins Successful event! Advertising for park via front page article in the Flyer over all other Halloween events held that week. Project A.N.G.E.L. concessions sales a success! HUGE kudos to my staff the event could not have been carried out in the fashion that it was without them!

 Project A.N.G.E.L. in attendance; expect a high turnout; cross marketing with the Bartlett Chapel to increase visibility
