June was a busy month at the fire department. I am writing this report on Friday afternoon after everyone has left the office and after the time that my report was to be in to Josie so that we could have your reports ready by 4:30 today.

This afternoon I went to Indianapolis EMS to pick up supplies and was on the way home when our guys were dispatched to a hazardous materials run at Plainfield. There was an acid leak at a bottled water company there and our personnel provided decontamination for the haz mat entry team and our staff provided support in the EMS and Accountability Sectors.

This morning started with a meeting of the Work Performance Evaluation Committee as they meet to forward our evaluation process. We are in the closing phases of evaluating tasks and functions that are specific to our department, and even though our final product will have some similarities with other departments around the US, we will have some components that are new and specific to our department. We will soon be deciding what components will be a part of our evaluation, as well as time parameters. We will then begin constructing the testing grounds and preparing personnel to train for the process.

Today was the deadline for our hiring process. At the closing time for the process, we had received 5 applications for the process. Next week I will be presenting some of the testing components to the Safety Board for approval. Our next step in the process is to review the applications for completeness. After reviewing the applications, we will have a written test administered by an outside organization on August 11. I have included some of the information

surrounding the process for your review. One correction is that the psychomotor testing will be September 4 & 5 since the 3rd is a holiday.

Last week we did complete grants for the replacement of one of our engines, one ambulance as well as new heart monitors. It will most likely be several months before we will hear the outcomes of those grants. We did purchase new helmets and hoods last week for our current grant, and we are awaiting competitive bids from our turnout gear manufacturer so that it can be purchased. We will most likely be purchasing our gear washer in the next two weeks. Unfortunately, we did hear last week that we were unsuccessful in getting our grant from Firehouse Subs for our needed workout equipment. We will continue to pursue other avenues to help in the replacement of that equipment.

Last week the Hendricks County Fire Chief's voted to approve one our personnel as the new coordinator for Project Lifesaver. This program is a non-for-profit organization that provides tracking mechanisms for at risk children and adults that could possibly become disoriented or lost. Bill Webb, one of our chauffeurs will be heading up the program. The position is non-gratis and Bill will not be paid for the position, so the department will supports Bill in any way we can in being successful in this endeavor, including allowing him time on shift to do work related to the project.

In June, our Prevention/Inspection Division did more fire investigations in one month than we ever have. In addition, at this point in the year, we have already exceeded the number of fire investigations that we did in the total of 2011.

Much of my time the past several weeks has been occupied by reviewing and preparing my budget. I have presented one budget, and then after talking with Pat and Don, revised the first copy to make needed changes. As a basis, I have worked to provide a 3% raise for personnel as well as some additional funds within items such as turnout gear purchases that need to be increased. As a final figure, I stayed within an overall 3% figure that was agreed upon by Pat. I have had discussions with the trustee and feel that our budget has been cut to the point that it is in our best interest to anticipate a 3% increase and utilize it if it is available. I also believe that if we create to lean of a budget, we cannot survive unexpected shortfalls, and we eventually create an environment where we only provide additional money to other agencies that are more than willing to absorb our decreases. I look forward to your input at the budget workshop.

Included with last year's budget was a 5 year plan that I have advised the board that I plan to evaluate and update. Because of many other commitments that have taken my time, I have not included this task with the budget preparation. I hope to have the updated plan completed for next month's meeting. I also hope to give you an updated status report on the Squad project next month,


