I then left Baltimore to travel to Vegas for a hazmat class. Unfortunately, I did not get to my room last night until 11:30, and as you may or may not know, it is three hours difference in Vegas. Last month, the Fire Department Instructor's Convention was in Indianapolis. Several of our personnel took advantage of courses and spent many hours looking at new equipment from vendors. We were very grateful the Don, Pat and Doug took the time to stop by and tour some of the vendor booths and become better educated in some of the aspects of the fire department. We were able to purchase a new ventilation fan at a discount and got valuable information from vendors about the vehicles that we will be purchasing soon, as well as turnout gear and washers. Thanks to

Chief Adams for spending a great deal of time working there and obtaining our passes for us for free Last month, the Merit Board met and gave us permission to begin distributing applications, so Chief Adams, Lt. East and I are finalizing the application packet. We will advertise our process in the local papers, on our web site and on Facebook. The board has also scheduled a meeting this month to review the final testing processes and the point percentages that go with the process.

On May 1 at 0700, our Squad 141 was put into service. We had a few adjustments that we needed to make the first day, but we are working out the bugs and moving forward. We look forward to seeing how the program works in the future. As part of the staffing process, we have decided to staff the vehicles with two personnel for safety reasons. To make staffing equal across all three shifts, A shift has been approved to hire back one person per shift the fill the vacant personnel position that we currently have.

In the coming month, we hope to have our specifications completed for our new engine. Once we have advertised for bids, it will most likely take 4-6 months delivery time for the vehicle. We also hope to have competitive bids for turnout gear so that it can be purchased. We have already collected bids for the washer and hope to purchase it soon. We hope that in the next 60-90 days, the ambulance specs will be complete and ready to go to bid.

Last month, Kingsway Christian Church was kind enough again this year to send congregation members to our stations to mulch beds and complete yard work. We had also planned some exterior painted that could not be completed because of the weather. The mulch was provided by Kingsway at no charge, and the members that came to work at the stations also brought care packages to our shift personnel. We would like to again thank Kingsway for the thoughtfulness and caring for our people.


