### **Administrative Update**

- Stephani and I had the opportunity to attend the 2017 Leadership Retreat in northern Indiana. 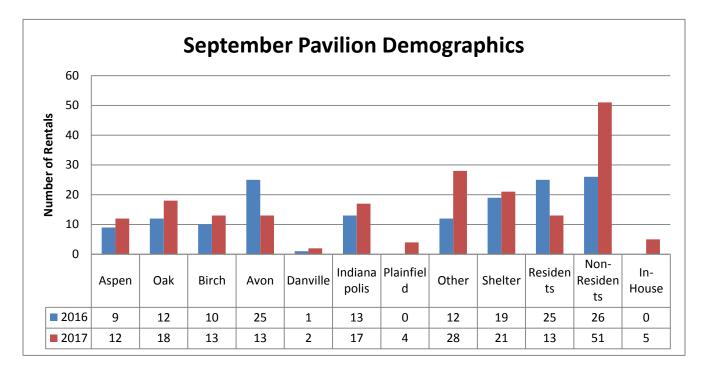
